It's summer in the city and while we're trying to prevent ourselves from melting, it's time to catch you up on what's happened and what to expect in the coming months. We've seen the historic conclusion of *Senator Clinton's Presidential campaign*. See the heartfelt essay by VP Rachelle Suissa on page 2. We marked International Women's Day with *"Women Take the Lead,"* a wonderful discussion about issues confronting women today. Our presenters, Barbara Winslow, Jenny Sunderland, Velmanette Montgomery, Yvonne Graham, all BQNOW members, and Lydia Devine spoke passionately about what we've achieved and what remains to be done to advance women's rights.

We've had a *legal success*, which protects us from discrimination based on gender identity, a *partial victory* (one-house-passed bills) protecting nursing mothers, and a "*go nowhere*" hope for state legislation protecting abortion rights (Reproductive Health and Privacy Protection Act – no bill proposed during this session).

Let us not forget that this November, not only will we be voting for President, but for every seat in the US House of Representatives and for every seat in the NYS Assembly and Senate. *Primary Date* for these offices is September 9th. The *General Election* will be November 4th. Make sure you are registered (Deadlines: August 15th for the Primary, and October 10th for the General Election) to vote!!!!! Then, show up at the polls!

We encourage candidates for state and federal office who seek NOW support to download our **BQNOW PAC Questionnaire** from the website. As you know, we cannot endorse at the statewide or federal level, but we can recommend endorsement to National NOW and NOW-NYS. Control League (which eventually became Planned Parenthood). In 1916, Sanger opened a family planning and birth control clinic at 46 Amboy Street in the Brownsville section of Brooklyn, which Montgomery represents in the State Senate.

As the Ranking Democrat on the Senate Social Services, Children and Families Committee, Senator Montgomery is recognized for co-sponsoring laws creating the Child Care Resource and Referral Agencies, prohibiting the ritual practice of female genital mutilation, and giving mothers the right to breast feed their babies in any public or private location.

Senator Montgomery is credited with helping frame the Women's Health and Wellness Law, which expands women's access to reproductive and other preventive health services. She is also a proponent of school-based health centers, and believes that age-appropriate, medically-accurate sex education should be taught from kindergarten through the 12th Grade.

Legislative Victory!!! Gender Identity Protection is now law!

The Gender Expression Non-Discrimination Act (GENDA) prohibits discrimination based on gender identity or expression; defines "gender identity or expression" as having or being perceived as having a gender identity, self image, appearance, behavior or expression whether or not that gender identity, self image, appearance, behavior or expression is different from that traditionally associated with the sex assigned to that person at birth; further includes offenses regarding gender identity or expression within the list of offenses subject to treatment as hate

On the legislative front, there are two bills involving *breastfeeding* that you need to watch.

In the House of Representatives, the bill is **HR 2236** - The Breastfeeding Promotion Act of 2007. Introduced in May of 2007 by lead sponsor Rep. Carolyn Maloney, it now sits in the sub-committee on Health, Employment, Labor and Pensions. The bill, as the title suggests, encourages the healthy practice of breastfeeding by amending the Civil Rights Act of 1964 to protect breastfeeding and the expressing of breast milk and to provide tax incentives to encourage breastfeeding. There is no companion bill in the US Senate.

In New York State, we have a bill, **A3782D**, coming out of the Assembly with a virtually unanimous positive vote. Sponsored by Assem. Gunther, the bill provides for a basic breastfeeding bill of rights. Unfortunately, its companion bill in the State Senate, **S1674D**, sponsored by Sen. Krueger, has stalled. These bills provide mothers with basic breastfeeding rights, which would then be posted conspicuously in mothers' healthcare facilities.

The NYS Legislature has still taken no action on *Reproductive Health and Privacy Protection* (S05829 no NYS Assembly companion bill). The bill has been languishing in the Senate Health Committee since January. That means if the US Supreme Court rules to overturn or more severely restrict access to abortion and family planning, there is no NYS law to protect our citizens and guarantee access to these services. Pressure every candidate asking for your vote for state office to get behind this legislation!

We will keep you posted on the progress of these bills, or lack thereof, but we also encourage you to pressure your representatives, both national and state, to get these bills out of committee and into law. Check out our website
