### WOMENS' EQUALITY ACT

At the 2013 State of the State address Governor Cuomo announced plans to promote a 10-point Women's Equality Act. . This groundbreaking, comprehensive legislative agenda will level the playing field and break down barriers so women can fully and equally participate in society.

- 1. **Protect Reproductive Health and Choice**: This measure ensures that every woman in New York State can get the health care she needs.
- 2. **Achieve Pay Equity:** This measure strengthens existing laws and enforcement measures to close the wage gap.
- 3. **Stop Sexual Harassment in All Workplaces**: This measure closes loopholes in existing law to protect employees of any business, large and

small, from sexual harassment.

- 4. Allow for Attorneys' Fees in Employment, Lending and Credit Discrimination Cases: This measure amends state law to include a provision for reasonable attorneys' fees for successful litigants, and ensures that discrimination victims have an opportunity to vindicate their rights.
- 5. **Strengthen Human Trafficking Laws**: Sex-trafficking victims are almost always women. This measure creates an affirmative defense in prostitution prosecutions for defendants who are sextrafficking victims.
- 6. **End Family Status Discrimination**: This proposal prohibits employers from denying work or promotion to workers

simply because they have children.

- 7. **Stop Source-of-Income Discrimination:**Many landlords will not rent to people who need low-income housing assistance, the overwhelming majority of whom are women.
  This measure prohibits discrimination against tenants based on lawful sources of income.
- 8. Stop Housing Discrimination for Victims of Domestic Violence: State law does not protect domestic violence victims from housing discrimination, meaning landlords can evict them under zero tolerance policies. This measure protects victims of domestic violence from discrimination when they attempt to purchase, rent or lease housing.
- 9. **Stop Pregnancy Discrimination Once and For All:** Too often, women are fired or forced to take unpaid leave because employers are not required to make minor job modifications for pregnant women. This measure requires employers to provide reasonable accommodations for pregnancy-related conditions.
- 10. Protect Victims of Domestic Violence by Strengthening Order-of-Protection Laws: Getting an Order of Protection can be difficult. This measure lifts some of the requirements of the process to make it less burdensome.

#### "Guns make women safer" ??

That's what Gayle Trotter, a conservative gun advocate, said at Wednesday's Senate hearing on gun violence.<sup>1</sup> At the hearing, one conservative witness after another argued vehemently against background checks, against limiting high capacity ammunition clips, and for assault weapons.<sup>2</sup>

But here's the inconvenient truth: The presence of a gun in a domestic violence situation increases the chance that a woman will be murdered by 500%. And here's another: In states that require a background check for every handgun sale, 38% fewer women are shot to death by partners.

#### **NEW PRESIDENT FOR NOW-NYS**

This past November, Zenaida Mendez was elected as president of the New York chapter of the National Organization of Women (NOW-NYS), It is the largest women's political action organization in New York, representing over 14,000 women and men in 24 chapters.

In addition to serving as president of NOW-NYS, Mendez is the Director of External Affairs at the Manhattan Neighborhood Network; the president and founder of the National Dominican Women's Caucus, and a mother of three daughters. She is also the first Dominican woman to be elected to the executive leadership post at NOW-NYS.

Now, native women, who endure much higher rates of rape and domestic violence than the general population, will finally have more avenues to justice. LGBT people, who experience domestic abuse at a similar rate to straight couples, will no longer be discriminated against when they seek help from shelters and other services.

#### GOOD LAW FOR WOMEN

U.S. Senator Frank R. Lautenberg (D-NJ) and Representative Carolyn Maloney (D-NY-12) reintroduced legislation to protect a woman's fundamental right of access to legal contraception. Lautenberg's and Maloney's bill, the **Access to Birth Control (ABC) Act,** would prevent pharmacies from denying the sale of contraceptives because of a pharmacy employee's religious beliefs. Because of the importance of birth control for women's preventive health care, new health insurance requirements under the Affordable Care Act now make birth control available to women without copays.
