Why didn't we endorse the only woman running? We regret that Christine Quinn proved to be such a disappointing candidate. Her record of: backing Mayor Bloomberg's overturning of term limits, opposing the Living Wage Bill and the Five-Day Sick Leave Bill demonstrated her loyalty to Big Business and not to the working women of this city.

John Liu, on the other hand, has demonstrated his concern for women. As City Councilman he was with us every week when we demonstrated for antisexual trafficking legislation. As Comptroller he demonstrated the need for Pay Equity legislation by conducting an investigation of pay inequities in corporations doing business with the city.

NOW-NYC, Planned Parenthood, and NARAL Pro-Choice New York have *endorsed Scott Stringer* for comptroller.

Sonia Ossorio - president of NOW-NYC - said that Elliot Spitzer's "hypocrisy" for patronizing hookers after signing legislation to stiffen punishments on johns played a role in her decision-making process. She also said that the former governor's participation in an industry that promotes the degradation and trafficking of women was something she couldn't tolerate.

Court Orders FDA to Remove All Restrictions on the Morning After Pill



Feminists win access to the morning-after pill (MAP) for all women and girls in the U.S! Ten years of speakouts, consciousness-raising, petition gathering, phonebanking, flashmobs, sitting-in and putting pressure on the Food and Drug Administration helped make this court decision possible. Women cannot be on equal footing with men if we can't decide when and if we will bear a child. Morning-after pill over-the-counter gives women an enormous freedom. *Organizing pays!*

Prior to the court's ruling, emergency contraception was kept behind a counter, only available without a prescription for women age 17 and older, and government issued identification had to be shown to buy it. The lawsuit, originally filed on January 21, 2005, uncovered evidence that President Bush's Administration pressured FDA review staff to enact an age limit on the pill for political reasons. In December 2011, the FDA finally decided to eliminate the unnecessary age restriction, but in an unprecedented move, Dept of Health and Human Services blocked the change with President Obama's support!

Plaintiff and National Women's Liberation organizer **Erin Mahoney** (& BQ NOW chapter member) said,

"The Morning-After Pill was already available without a prescription in at least 63 other countries, including the United Kingdom, France, Denmark and Ghana. We are glad the U.S. has finally caught up to women around the world, but it shouldn't have taken over a decade of pressure from feminists, our allies and a lawsuit."



END SEXUAL ASSAULT IN THE MILITARY

Senator Kirsten Gillibrand is a major sponsor of the *Military Justice Improvement Act*.

26,000 instances of sexual assault and unwanted sexual contact in our military in one year is heartbreaking. Survivors have been silenced, the rising number of assaults and horrific news stories of justice denied point to the desperate need for bold reform, oversight and accountability.

And yet, unacceptably, bipartisan legislation to transfer prosecution of sexual assaults to independent trained military prosecutors has been stopped.

The assaults themselves are appalling, but worse is when victims are re-victimized by a system that fails them. Too many victim's cases are swept under the rug, allowing predators to repeat their crimes.

It's created a broken culture that can't be allowed to continue. **Time and again, victims are failed.**

Our servicemen and women deserve a vote and a system of justice that is equal to their sacrifices.

NYS Legislature Fails to Pass Women's Equality Act

Although the NYS Assembly passed the Women's Equality Act the Senate refused to introduce any bill that dealt with abortion rights. The abortion segment of the bill would simply have brought NYS's reproductive rights law up to the Federal standard and would clarify that only licensed medical professionals should set the medical standards.

Instead the Senate broke the bill into 10 separate measures and passed 9. The bill then went back to the Assembly. They refused to pass the law without the abortion rights provision. This resulted in none of the 10 points of the WEA passing.

Although we will continue to push for the reproductive rights portion of the bill we must contend with the fact that the anti-choice State Senate will remain intransigent. We can still get passage of 9 important provisions of the WEA We are asking the Governor to call a special session to vote on the bill passed by the Senate.

Call your Assembly member at their local office and ask that he/she pass the 9 WEA bills already passed by the Senate. (for contact information, go to http://assembly.state.ny.us/mem/)

Here's what you can say/write/fax:

Assembly member____

I live in your district. Thank you for voting for the WEA. Please do what you can to get as many measures of WEA as possible passed into law. Vote for the 9 Senate-passed WEA bills. These issues are too important to have them languish due to partisan politics. Women deserve relief from discrimination NOW. Thank you again your support of the Governor's Women's Equality Act.

National NOW Conference 2013

This year's National NOW Conference featured an array of speakers, panels, plenaries and events of interest to women from all around the country. The guest of honor was the **Reverend Jessie Jackson**, whose speech dealt with the commonalities of the women's rights movement and the civil rights movement in the United States.

The conference featured a number of interesting workshops, including: the role of teachers' unions in Chicago, the struggle to increase the minimum wage around the country, the passage of the 20-week abortion ban in the House of Representatives, and local initiatives to protect and preserve birth control access for women of all ages. **Saru Jayaraman**, a professor of political science at Brooklyn College, received the Woman of Honor Award for her work with the Restaurant Opportunities Center, which promotes awareness of company tipping policies and works to increase the minimum wage for restaurant workers, many of whom work in substandard conditions, without paid sick or parental leave. The Restaurant Opportunities Center now has movements in Chicago, Houston, Los Angeles, Miami, Michigan, New Orleans, New York, Philadelphia and Washington, D.C.

The Conference also featured. a *Feminist Flash Mob*, in which women gathered in the streets to dance to a feminist song—it really stirred the crowd! National NOW President **Terry O'Neill**, who ran unopposed, was reelected to another term. She made it clear that one of the main goals of NOW is to increase diversity throughout the organization. **Chitra Punjabi** was elected Vice-President of Membership. We look forward to working with National on issues of importance to women and girls.
